She will talk to the Cabinet Member at BCC who is responsible.

The changes to the proposed extension to the Community Library which will require permission from Banks Park Trust as the freeholder of the land, were noted. The Trustees of the Library intend to submit a new planning application soon and are trying to resolve issues regarding the use of S106 funding with AVDC.

A draft lease has been received following negotiations between solicitors. The Parish Council solicitor has raised a number of questions that will need clarification. It was DELEGATED to the Clerk and Mr. Truesdale to clarify these points and make a recommendation to the Trustees.
