Aston Road (Glebe Site – Dandara)

Dandara has agreed to the Parish Council's request to look at locations for installing additional dog bins. It is also prepared in principle to consider accommodating silt that may be dredged from Church End pond on the proposed burial ground site as the site levels require raising. Dandara is willing to permit reLEAF to plant additional hedging along the footpath to Churchway.
