P22 122 APOLOGIES

Apologies were received from Cllr. O'Hanlon for joining the meeting remotely.

The Chair agreed that Cllr. O'Hanlon should be allowed to participate remotely on any agenda item, however cannot vote under current legislation which requires councillors to be present in the room.

P22 124 MINUTES

The minutes of the meeting held on 14th March 2022 were AGREED as a true record and signed.

P22 125 PLANNING APPLICATIONS

The Parish Council's response to the following planning applications were AGREED:

(i) 22/00575/APP & 22/00576/ALB 17 Church End Haddenham Buckinghamshire HP17 8AE Listed building application for conversion of garage into habitable space and single storey rear extension

The Parish Council has no objection in principle, subject to

a) the Heritage Officer's comments and

- b) the correction of the discrepancy between the ground floor plan showing new doors from the study to back garden and the rear elevation showing the existing window retained. The Parish Council would prefer to see the window retained.
- (ii) 22/00836/ALB Byre House Dollicott Haddenham Buckinghamshire HP17 8JG Listed building application for formalisation of works previously undertaken and alterations to interior and exterior of barn (retrospective)

 The Parish Council has no objection subject to the Heritage Officer's comments.
- (iii) 22/00877/APP Stockwell Farm 17 High Street Haddenham Buckinghamshire HP17 8ES Householder application for single storey outbuilding The Parish Council has no objection subject to a condition requiring the outbuilding to remain ancillary to the principal dwelling and not let or used as independent habitable accommodation.

P22 127 TIBBS ROAD PAVILION

A site meeting was held on 16th March. The bricklaying has now started, is progressing well and the quality of the work is good. Time has not yet been made up from earlier delays so the project is now approximately 7 weeks behind schedule. 5.5 of the lost days are due to bad weather and an extension of time may be requested for these as permitted within the contract.

The Parish Council received a complaint about the amount of dust blowing from the site to the neighbouring properties on Westland Close when brick cutting is taking place. Marlow has adjusted their practices by hiring a block cutter and a better wet cutting machine which should reduce the amount of dust generated.

The loss of the gate onto the playing field where the pavilion is being built means alternative emergency access is needed. There is a dropped kerb in the car park that is a good alternative but the area of the car park in front of it will need to be hatched to prevent parking and removable bollards are recommended. The Clerk has arranged for RoSPA to carry out a site risk assessment to ensure any other unidentified risks can be minimised.

P22 128 STREETSCAPES UPDATE

A remote meeting was held with consultants PJA, who have been collating the results from the <u>bucks.place survey</u>. Public consultation on the project will be held on **Thursday 28th April 1pm-8pm** in the conference room at Haddenham Village Hall. Members of public are welcome to attend and discuss issues and options, ideas, likes and dislikes.

P22 129 UPDATES ON MAJOR DEVELOPMENTS

Airfield site (CALA Homes)

Nothing to update.

Aston Road (Glebe Site – Dandara)

Planning permission has been granted for 85 dwellings in the final phase (20/03764/APP). A meeting was held on site with Buckinghamshire Council and Dandara regarding the shared access part of the footpath running behind Willis Road. Dandara is pricing up two potential options to improve the footpath. Buckinghamshire Council is currently refusing to fund any improvements.

Dollicott (CALA Homes)

Nothing to update.

Land West of Churchway (HAD007)

Additional drawings, largely amendments to the proposed house types, and a covering letter have been added to Buckinghamshire Council's online planning portal. The letters states that a witchert wall must be provided on the northern boundary of the site according to the design code, however this is Redrow's own design code. The letter also advises that the Local Lead Flood Association (LLFA) has removed its objection to the proposal, but the LLFA has actually requested a condition that a full statement and proposals are made to them, suggesting these are still yet to be provided. Additionally, the letter states that Thames Water has no objection but in fact Thames Water has commented that it has yet to see any proposals for foul or fresh water to the site.

Cllr. Smith is trying to arrange a meeting with Redrow to address the Parish Council's concerns.

Land South of Lower Road
