P24 1 VICE-CHAIR

P24 7 S106 PROJECTS

It was AGREED to recommend the following sport and leisure projects for inclusion in the Section 106 agreement for 23/00311/AOP - Land At Churchway Haddenham, if it were to be approved:

- Improvements to or replacement of the pavilion at Woodways Recreation Ground.
- Improvements to or replacement of Haddenham Village Hall.
- Provision of a pavilion, and associated car park at Aston Road.
- The provision of a youth leisure facility in Haddenham.

P24 8 STREETSCAPE UPDATE

The Thame Road design report from Phil Jones Associates was received. It was noted that the report has been submitted to Buckinghamshire Council. The report and further background on the Streetscape project is available on the <u>Parish Council website</u>.

Support from Haddenham's Buckinghamshire Councillors may be needed to ensure that Buckinghamshire Council engage with the plans in a timely manner so that the Section 106 funding that has been allocated for walking and cycling improvements to Thame Road can be used before it expires.

P24 9 APPEALS

P24 10 UPDATES ON MAJOR DEVELOPMENTS

Airfield site (CALA Homes)

Cala has asked for an inspection of the western buffer parcel to be carried out as layout is complete. This is the area Land Improvement Homes wish to retain ownership of so there would be no maintenance period, just a final sign-off.

Aston Road (Glebe Site - Dandara)

A site visit was carried out on 17th May, attended by Buckinghamshire Council Section 106 and Ecology Officers, Dandara and Parish Council representatives. It was agreed that subject to some minor ground work, replacement tree planting in the autumn and a play area inspection and repairs, the land forming parcel 1 (yellow on plan) is ready to be transferred to the Parish Council. It was suggested the transfer date to aim for is 1st July to allow the legal team time and tie in with the new open spaces maintenance contract.

Land West of Churchway (HAD007)

Work appears to have restarted onsite, but to date the decision notice has still not been issued for the surface water drainage. A review of Buckinghamshire Council's planning website shows no update from Buckinghamshire Council since the Enforcement Notice was issued. In summary:

- there have been 15 planning applications
- 4 of these remain outstanding pending decisions
- There is a live Enforcement Notice in place requiring re-instatement of the land
- Site work is clearly proceeding.

The 4 outstanding applications are:

- 17/E2280/DIS drainage & flooding
- 22/03485/VRC witchert wall, plus details of doors, porches etc.
- 21/A0215/DIS electric vehicle charging points
- 21/C0215/NON various amendments to house types

It is hoped that Haddenham's Buckinghamshire Councillors may be able to find out what is happening. Cllr. Smith will continue to raise the issue with Buckinghamshire Council.

Land adjacent to Haddenham Garden Centre

Nothing to update.

P24 11 CORRESPONDENCE AND ITEMS FOR THE NEXT AGEND

A few queries have been received regarding future plans for land at the Aston Road site when it is transferred over to Parish Council ownership. A burial ground, cricket pitch and sports pavilion are planned. Concerns have been raised about the soil that Dandara is using to raise site levels. Dandara has advised that one lorry load of material was rejected last week as being incorrect. The site will need to be approved by the environment agency, who will assess site levels, before a burial ground can be built.

Cllr. Truesdale reported that a group of leaders from local government and Local Enterprise Partnerships are forming a new partnership for the Oxford to Cambridge area, however, Buckinghamshire Council doesn't appear to be involved.
