P25 108 UPDATES ON MAJOR DEVELOPMENTS

Airfield Site

The PC's solicitor has started working on the transfer of phase 2 again. The Facilities Manager and Clerk have carried out another site inspection and found there are still some outstanding maintenance tasks from the previous inspection that we have asked to be carried out. The report has been sent to CALA and we are awaiting a response.

Aston Road (Glebe Site – Dandara)

An inspection of the phase 2 land has been carried out by the Facilities Manager and the Clerk. Bucks Council haven't issued a provisional certificate but are happy to rely on the Parish Council's acceptance of the condition of the areas for adoption. Some maintenance and remedial work are needed and a report has been shared with Dandara.

Land West of Churchway (HAD007)

No updates.

Land At Dollicott – Platers Road

The transfer document has been signed by HPC and we are waiting for confirmation that it has been signed by CALA and the commuted sum paid.

Aston Road Pavilion

Planning permission has now been granted and we have scheduled a meeting with PCMS Design to finalise the specification before going out to tender.

Neighbourhood Plan

Key stakeholders' meetings are now underway for the scoping exercise for future development in the village. HPC have contacted the Patients Participation Group (PPG) for the Medical Centre and had a meeting with the new chair Brian Rogers. Requests from the Bucks Oxon & Berks Integrated Care Group for a S106 contribution for the medical centre in response to recent hostile planning applications have been shared.

P25 110 CORRESPONDENCE AND ITEMS FOR THE NEXT AGENDA

Townside: residents have raised concerns about a shepherd's hut being installed in one of the neighbouring properties. Cllr Truesdale has advised them to contact Bucks Council enforcement team as it is within a conservation area and quite visible so there may be a breach of planning rules.

Lawful development certificates: The Chair had noted that the Levelling Up and Regeneration Act 2024 had changed the period of time from 4 years to 10 years for development to become lawful, which gives a longer period for people to raise a concern.

Stanbridge Road: need to remind the home owner that the fence on Green Lane needs to be moved.
