#### B25 41 REPAIRS AND REFURBISHMENT TO BANKS PARK CAR PARK

Five companies were approached to provide quotes for the repairs and improvements to Banks Park Car Park, only two quotes were received in time for the meeting despite chasing several times. It was AGREED to appoint Total Landscapes to carry out the following work: Repair of pot holes £1044 gross

Realignment and resurfacing of pedestrian access from Churchway £3996 gross Improvements to drainage and relaying path to Scout & Guide Centre £2148 gross

#### B25 42 RENT REVIEWS

- (i) The rent for FitLife Gym due in November 2024 remains unpaid. The rent is due for its 3year review, which has previously been done in line with RPI. FitLife Propco who lease the building have queried the calculation of the rent but have not explained why, or offered and alternative mechanism for discussion. The Clerk was asked to chase this again.
- (ii) It was noted that Haddenham Community Library rent is due for its 14 year review due in November 2025. The Clerk has contacted the relevant officer at Buckinghamshire Council

and agreed the method of calculation of the increase, which will be using the All Items RPI Index for September 2025.
