- (iv) The 14 year increase in ground rent for the library is due in 2026, and the mechanism of previous reviews is not clear. Contact has been made with Bucks Council and an Officer has suggested a calculation based of RPI increase each year since the last review. This is acceptable and will be used next year. The rent for 2025 will remain £300.
- (v) A 3-year review is due in 2025 and will be carried out in accordance with the rent review clause in the lease, using the RPI All Items Index for October 2025 when it is available.
