B26 22 BANKS COTTAGE EXTENSION

The tender for the extension to the cottage was published on Find a Tender on 18th February 2026. The timetable for the project has been set as follows:

- Pre-Qualification Questionnaire returns: by 11 March 2026
- Invitation to Tender returns: by 08 April 2026
- Award of contract: 07 May 2026, subject to approval by both HPC and HDC as well as being subject to the statutory standstill period.
- Construction start date: 04 June 2026 with completion date: 28 January 2027

A meeting has been held with Dr. Patel from Haddenham Dental to progress with the terms of the agreement for the funding and management of the project. The Parish Council is funding the cost of the building construction and Haddenham Dental will fund the fixtures and fittings, which they are responsible for under the terms of their lease.

The Clerk has received VAT advice which confirms that the Parish Council can reclaim the VAT on the construction work, but not on the fitting out of the surgery as the parish council is not responsible for their ongoing maintenance. Haddenham Dental will be invoiced for their portion of the cost including the VAT.
